Pathways Tracking: Background

Since the start of the project, applicants who have participated in Pathways to the Professions are tracked each year to see the outcome of their UCAS application and, in subsequent years, their progress through their course and degree outcomes. All Pathways students who applied for one of the four Pathways strands at the University of Edinburgh are included in the tracking data. All of these applicants are then tracked on an annual basis, if they entered the University of Edinburgh (nb: Pathways staff only have access to the UCAS record of an applicant if he / she applied to the University of Edinburgh).

From 2012 onwards, it was decided that Pathways applicants would be re-tracked back as far as entry 2006. This was to ensure that applicants who had reapplied in subsequent years after initial unsuccessful applications were picked up wherever possible. Pathways staff are able to access much of this information - from 2006 onwards - using "UCAS Weblink". This process was continued in our tracking for 2013.

The following report shows application and entrants numbers, as well as annual tracking of progress and, where relevant, degree outcomes. This new way of tracking has also allowed deferred entry applicants to be tracked more robustly.
